## 2011 IMEA State Convention Performing Group Application Guidelines

1. Each group's application must be accompanied by a new, high quality audiocassette or CD.
2. The name of the group must appear on the outer case, not on the media itself.
3. The recording must include three contrasting pieces that were performed within the past 12 months and are representative of the group's repertoire and ability.
4. Titles and composers of the selections should be included on the CD or cassette. Identify the track or tape location of each selection and allow clear separations between the pieces.
5. Directors must be members of MENC at the time of application submission and performance.
6. Submission of a completed application implies that the group will appear, if chosen, and has the unqualified support of the administration of their school or college, including necessary financial support. IMEA is not responsible for any housing, travel, or meal expenses for the group.
7. IMEA Policy states the following about students chosen for All-State groups whose school ensemble is also performing at the convention:
  - a. Any student who is selected to participate in an All-State or Honor group shall be excused from the All-State rehearsal to perform with an ensemble from his/her school at the convention
  - b. No student shall participate in more than one All-State or Honor group each year.
  - c. Failure to comply could result in the loss of rehearsal space, performance space, and/or any other financial support from IMEA (for the sponsoring organization). Final authority regarding this policy rests with the IMEA Executive Committee.
8. Selection will be made by the Convention Planning Committee and the Convention Chair in mid-March, 2010. Selection will be determined by quality of performance, but the necessity of a well-balanced program and geographical representation from the state will also be taken into consideration.
9. Recordings will not be returned.
10. Recordings/recommendations must be sent to **Michelle Oyler, 2011 IMEA Convention Chair, 8343 S Midnight Drive, Pendleton, IN 46064, postmarked by March 1, 2010, in order to be considered.**
